- Ensuring strong fiduciary oversight and financial management
- Fundraising and resource development
- Approving and monitoring wsg's programs and services
- Enhancing wsg's public image
- Assessing its own performance as the governing body of the wsg

EXPECTATIONS OF BOARD MEMBERS

Each individual board member is expected to:

- Know the organization's mission, policies, programs
- Faithfully read and understand the organization's financial statements
- Serve as an active advocate and ambassador for the organization and fully engage in identifying and securing the financial resources and partnerships necessary for WSG to advance its mission
- Leverage connections, networks, and resources to develop collective action to achieve wsg's mission fully
- Give a personally meaningful financial donation
- Help identify personal connections that can benefit the organization's fundraising and reputational standing and can influence public policy
- Prepare for, attend, and conscientiously participate in board meetings
- Participate fully in one or more committees
